NEW RAIL TRAILS UNDER CONSTRUCTION by John Frederick, Guest Columnist

The Bells Gap Railroad Trail

The Bells Gap Railroad was introduced as a narrow gauge spur line in the 1850's with the intention of connecting the Pennsylvania Railroad Mainline to the people and resources in the northern portions of Pennsylvania. It would move people and goods northwest and would help the coal and lumber industry to the west move their goods to the cities along the Mainline and beyond.

The spur line connected to the Mainline in the center of Bellwood, near where the Bellwood-Antis Community Park is now located. Eventually, the spur would be converted to a standard gauge line in 1872, allowing easy exchange of cars and the goods they carried. Though the slope was steep and the ascent of the Allegheny Front was slow and difficult, the line was an important transportational artery for both goods and people until the current Route 865 was improved in the 1930's.

Like most rail lines of the time, the builder and original owners, the Bells Gap Railroad Company, kept the incline below four percent. This could



only be accomplished by wrapping around some of the stream valleys on the escarpment to lengthen the horizontal distance of the climb. The most noteworthy of these is above the Bellwood Reservoir on Shaw Run. The curve near the confluence of Bells Gap and Shaw Run produces an exceptional view of the valley at Point Lookout trail users are now be able to enjoy.

At four percent, the slope of the right-of-way will provide for a gradual ascent well suited, not just for the railroads of the 19th century, but cyclists, hikers, cross-country skiers and horseback riders of the 21st. After leaving Bellwood Borough, the trail goes westward toward Roots Crossing. It parallels Route 865 toward the scenic Bellwood Reservoir. The Altoona City Water Authority has granted a right-of way through their watershed property above the reservoir. The trail then crosses through Pennsylvania State Game Lands, terminating in the village of Lloydsville at the top of Blandburg Mountain.

The trail meanders gently through the bends of the Allegheny Front, across mountain creeks and offers several stunning views of the valley.

Take a break at one of the many vistas to gaze out over the Tuckahoe Valley, enjoying the majesty of the rolling mountains and the tranquil blue waters of the reservoir. A few forgotten railroad spikes can still be found along the trail, rusted and corroded, a reminder of the industry that catapulted the dusty settlements of Bellwood and Blandburg into prosperity during the heyday of the railroad.

The Logan Valley Trail

The northern end of the Logan Valley Streetcar Trail is slated for construction in 2023 and will begin at the Route 865 Bridge. The trail will cross at the Bellwood Pedestrian Bridge and meet the lower end of the Bells Gap Trail. It parallels the path of the trolley line that connected Hollidaysburg, Altoona, Bellwood and Tyrone.



The Bellwood-Tyrone portion of the trolley ceased operation in 1936.

The Bells Gap Trail will go through the Bellwood-Antis Community Park, one spur going along Bells Gap Run until the trail transitions into a share-the-road route to Roots Crossing. Meanwhile, the Logan Valley Trail will turn south at the west end of the pedestrian bridge and follow Bells Gap Run southward to Becker Road. The trail will end just south of Becker Road for the time being until a coal waste reclamation project is completed. Following removal of the coal waste and replanting of the area, the trail will be finished south to Riggles Gap.

Connecting Our Communities, the Past and Present

This trail system will someday link not only westward toward Blandburg, but north and southward to Tyrone and Hollidaysburg. It will also connect past and present, through the men and women whose livelihoods once depended on the railroad. It recalls the days when it was the only dependable mode of transportation to connect these communities. The Logan Valley Trail goes back even further, once serving as a passage for Native Americans along the Little Juniata River.

It is our hope that future generations will follow its path for recreation, exercise, a greater appreciation of our natural beauty and resources, and a new understanding of the fascinating history behind Bellwood-Antis and Blair County. 

UNDER THE WIRE AMTRAN HOSTS BUS RODEO by Leonard Alwine

On Sunday, August 4th, Amtran hosted the Pennsylvania Public Transportation Association Rodeo at the Logan Valley Mall Parking lot. This was the third time Amtran hosted the rodeo, the first time was May 1988 and again in May 2008, then this year. Twenty drivers from various state bus authorities competed.

The top three state winners are then granted to compete in the American International Transportation Association International Bus Rodeo the following year.

This year, Amtran driver Joe Beach finished third and is now qualified to compete at the international event. This would be his third time at the international event having won the state event in 2022 (First Place) and also in 2019 (Third Place).

Amtran's other driver entered this year was Jamie Rickens, who finished seventh in this local state event. Jamie is a former member of the Horseshoe Curve Chapter NRHS and was sponsored by the chapter to Rail Camp in 2001. Perhaps by finishing seventh he proves that he is good driving both on and off the rails.

Amtran debuted it's Logan Valley heritage bus #56 in the 106th Annual Labor Day Parade held in down-town Altoona on August 31, 2024.

The bus is a 2024 Gillig natural gas powered bus which arrived at Amtran in late May with two sister buses in regular Amtran colors (see article in the Summer 2024 issue of the Coal Bucket). The bus was driven in the parade by Jamie Rickens who recently took 7th place in the bus rodeo hosted by Amtran on August 4, 2024.

Riding in the doorway of #56 was Joe Harella, a retired Amtran driver, passing out candy to all the kids along the parade route.

INCLINE STILL O.O.S. by Leonard Alwine

As of September 15, 2024, the incline at Horseshoe Curve was still out of service. It was announced at the chapter picnic held at the Curve on August 4, 2024 that it was expected to have the incline up and running again by the end of August. But that did not happen.

The incline and cars were installed sometime during 1991-1992 when the Horseshoe Curve historical site was rebuilt. The incline and cars were sort of a "one-off" by the manufacturer which is now out of business. This along with misplaced inspection and maintenance records from the beginning has caused a mountain of problems for the current landmark leaders. They are trying against all odds to get it running again.

It did actually venture out of its station and ran a little bit in mid July on what was hoped to be it's final inspection run. More problems just a short number of feet up the hill made more parts needed which had to be ordered from overseas.

Photo taken in July on what was hoped to be the final inspection trip shows the car stopped about 30 feet up the slope. At least it was trying to run after about four years stopped.



The big problem with things shut down and not running for four years is a two fold problem. One, anything not used for a long time will seize up, become stiff and maybe even rust or corrode. Perhaps that is some of the operating problems now.

And second, with it being shut down for such a long time, visitors to the park have maybe found other places to watch trains. And tourist bus lines are probably not listing the curve as a stop on their tours as many using this service are older and cannot walk the nearly 200 steps to the top.

Once reopened, it is going to take a major marketing effort to get the Curve back to it's original tourist attraction status.

Let's hope that it can be done and the Curve will once again be the premiere tourist attraction of the area. All rail enthusiasts should do all they can to help the local current historic landmark leaders re-establish the old Curve venue.

CHAPTER MEMBER PUBLISHES NEW BOOK by Leonard Alwine

Horseshoe Curve Chapter Member Jeffrey Holland has recently published a new book featuring the Altoona & Logan Valley roots and recording up to the present day Amtran. The book entitled "Amalgamated Transit Union Local 801" details the history of public transit in Altoona.

Mr. Holland is the son of W. Dale Holland, grandson of Jacob Grant Condron Sr., and nephew of Jacob Grant Condron Jr., all whom were members and officers of Local 801 and all long time employees of Logan Valley and Amtran.

With this family heritage background, Jeffrey has collected many photos and items from the past about the Local 801 and the Women's Auxiliary Division 801-A. They are very nicely interspaced into the pages of this writing. He has also researched and includes a page listing all the Presidents of the Local 801 with photos of them.

The book is a must have for anyone interested in the local transit history of Altoona and it is the first one of it's kind on this subject.

The second part of the book, "A Time Line of the Public Transit of Altoona" is a rehash of the City Passenger Railway, Altoona & Logan Valley Electric Railway and bus line and the Amtran buses of today.

That history has been documented before by books from Benson Rohrback, David Seidel and Leonard Alwine. But in this new book there are over two dozen never before published photos of trolleys and buses that Jeffrey has added to his collection over many years of collecting transit items. Again, he has included these items inside the pages of his book including many old tickets of the Altoona system.

He ends this part with eight employee photos, rosters given to employees from Logan Valley in 1915 to the time of Amtran's 60th Anniversary of 2016.

Mr. Holland is priviledged to have relatives working at the transit company over the years which allowed him to collect many first hand items which he shares in this book.




Photo of the cover of the new book.


A LOOK BACK by Leonard Alwine
