Articles of Association and Incorporation of the Frankfort and South Eastern Railroad Company

We, the undersigned desirous of organizing ourselves into a corporation for the purpose of constructing, operating and maintaining a railroad of three feet gauge between the points or places hereinafter more particularly specified and set forth within the State of Michigan, under the provisions of Act No. 198 of the Cession laws of said State for the year 1873, and of the acts amendatory thereof, do hereby in accordance with the requirements of said law, subscribe the following articles of association.

First

The name of the corporation hereby founded and constituted is and shall be The Frankfort and South Eastern Railroad Company.

Second

The number of years the said corporation is to be continued is nine hundred and ninety nine.

Third

The capital stock of said Company shall be one hundred thousand dollars (\$100,000) and consist of one thousand shares of one hundred dollars a share (with the right to increase said capital, under the laws to five hundred thousand of dollars of five thousand shares of one hundred dollars each, in case said road should be extended and constructed beyond the present prospective terminus to wit the upper Welden Bridge on Betsie river in the southeastern part of Weldon township in said County of Benzie.

Fourth

The number of Directors of said Company shall be five, and the following are the names and places of residence of each Director, viz:
